Pateley Bridge Town Council (PBTC), also known as High and Low Bishopside Parish Council, strongly opposes the Local Government Boundary Commission (LGBC)'s proposal to merge the current Pateley Bridge and Nidderdale Moors Division into the 'Wharfedale' division. This new division attempts to combine two distinct communities, geographically separated by a large upland area and connected only by the B6265. PBTC argues that such a merger fails to respect the unique historical, geographical, and social identity of Nidderdale, undermining effective representation and community cohesion.

PBTC emphasises the following points:

Dividing High and Low Bishopside Parish: The proposed boundary changes would divide our parish, placing Pateley Bridge in the Wharfedale Division while assigning Glasshouses and Wilsill to the Nidderdale Division. This fragmentation undermines cohesive local governance, forcing our Parish Council to coordinate with two separate NYC councillors. Such a split would lead to disjointed representation, complicate decision-making, and dilute our parish's unified voice in addressing community concerns.

Distinct Identities: Nidderdale and Wharfedale are separate communities with distinct historical ties, governance traditions, and practical affiliations. Nidderdale has always been associated with Harrogate, while Wharfedale aligns with Skipton, reflecting different service and cultural centres.

Geographical Challenges: The significant distance (approximately 30 miles and 1.5 hour's drive) between key settlements like Buckden (Wharfedale) and Middlesmoor (Nidderdale) makes it impractical for one councillor to effectively represent both areas and highlights the distinct separation of the communities.

Community and Cultural Cohesion: Nidderdale is a close-knit community with shared institutions, such as Nidderdale High School, Nidderdale Agricultural Society, and numerous other community organisations. Dividing the valley would weaken these bonds and dilute its unique identity.
